1. By adopting the animal(s) above, I recognize that Animal Foundation of America (AFA), the rescue groups with which they work, and any former foster parent or owner are not liable for any damages or injuries caused by the adopted animal(s).
2. I am adopting the animal(s) above for myself and no other person. I will keep identification tags on the animal(s) above at all times.
3. I understand that the health of the animal(s) above is now my full responsibility. All veterinary visits, including routine treatment and emergency room admissions, are my full responsibility.
4. If the animal(s) above is/are not currently altered, I agree to spay/neuter the animal(s) above when it/they reach SIX (6) MONTHS OF AGE or WITHIN THREE (3) MONTHS OF ADOPTION. If I choose to use a veterinarian of my choice, I agree to send proof of spay/neuter to AFA within TEN (10) DAYS of the surgery.
5. I will take the animal(s) above to a veterinarian each year for an examination and necessary vaccinations and other treatment.
6. I will keep the animal(s) above as a house pet(s). The animal(s) above will NOT be used for breeding or experimental purposes. I will NOT declaw the cat(s) above, and I will NOT let them outside.
7. I understand that the adoption fee is NOT refundable.
8. AFA may contact me for verification of the animal's welfare, and I will cooperate by providing whatever information is requested. I will permit AFA to reclaim the animal(s) above immediately if the welfare of the animal(s) is deemed in jeopardy.
9. If I become unable to care for the animal(s) above due to unforeseen circumstances and need to give the animal(s) up, I understand that I MUST return the animal(s) to AFA and that I CANNOT rehome the animal(s) or give it/them to any party other than AFA.
10. I do NOT hold AFA or the rescue groups with which they work responsible for errors in the information provided about the animal(s) above, including that which may cause unforeseen harm, injury, or medical emergencies. I am aware that I am adopting a live animal, which can unexpectedly require further medical treatment.
11. I understand that the actions of animals are often unpredictable, that animals should be closely supervised when they are with children, that the behavior of an animal may change once it becomes accustomed to a new environment, and that AFA and their partner rescue groups cannot be held responsible for the health, temperament, or mental disposition of the animal(s) above.
12. I understand that if I have given false information at any point during the application or adoption process or do not follow the terms of this contract, the animal(s) will be confiscated and legal proceedings will be started against me at my expense.
